'Instant tickets' to prompt property cleanups

Council votes to end lengthy criminal process By ADAM TAYLOR, The News Journal Posted Friday, October 20, 2006

WILMINGTON -- In April, city code inspectors will begin issuing \$50 tickets on the spot if they see high grass and weeds, litter or excessive animal waste on properties. Garbage cans left in front of buildings on days before trash is to be collected will be a cause for the fines as well.

City Council unanimously passed the "instant ticketing" program Thursday night.

The program was started because residents and city officials have been frustrated with the current process, which they say takes too long to get property owners or tenants to clean up. Currently, a judge fines the violator, often months after the citation is issued. Neighbors have to live with the nuisance properties during that time.

Councilman Charles M. Freel, the sponsor of the bill that made the program law, said he thinks it will do more than make Wilmington deaner. "The appearance of neighborhoods adds up to a stable community," he said.

Many landlords don't like the program, however, because the fines are imposed before the owners or tenants get a day in court.

Under the current system, code violations are criminal misdemeanors and the fines range from \$100 to \$5,000. The system that will begin in April makes them civil matters for property owners and reduces the fine. The lower, \$50 fine, however, doubles if it goes unpaid after a month. The current criminal system and fine structure will not change for tenants.

Those who are fined can appeal their tickets to the city.

Code inspectors will investigate cases at rental properties before deciding to fine the owner or the tenant, city Communications Director John Rago said.

But landlord Earl Smiddy told the council Thursday that often the litter in front of his properties is neither his fault nor that of his tenants. Pedestrians are the main culprits, he said.

"This ordinance is remedying the problem instead of eliminating the cause," he said. "If you're going to fine somebody, fine the person that does it."

In other business, the council approved four five-year contracts worth a total of \$5.2 million for engineering design work for a series of improvements to the city's water system. Metcalf and Eddy Inc. will get up to \$2.5 million, Whitman and Requardt and Associates will get up to \$1 million, O'Brien and Gere Inc. will get up to \$1 million and Malcolm Pierne Inc. will get up to \$700,000.

The contracts passed by 10-2 votes. Councilman Michael A. Brown Sr. was absent.

Councilman Charles Potter Jr. voted against the contracts because he feels the city's engineering staff is capable of doing some of the work. Mayor James M. Baker's chief of staff, William S. Montgomery, however, said the work needs firms that specialize in the field.

Councilwoman Loretta Walsh voted against three of them because she said they don't have offices in Wilmington. But Councilman Gerald

L. Brady, head of the council's Public Works Committee, said two of the firms, Metcalf and Eddy and Whitman Requardt, have local offices.
